Requesting Copies Of Your File ~

If you are picking your copies up in person, please bring CASH. No personal Checks, No Credit Cards, No Debit Cards will be accepted at this time. **Only Cash, a Money Order or a Cashiers Check –payable to the Yakima County Clerk- will be accepted.**

Photocopies (paper) of documents are \$1.00 minimum for the first 2 pages. After 2 pages the cost is \$.50 per page. All copies will be 8-1/2” x 11” in size.

Electronic copies (E-mail) of documents are \$1.00 minimum for the first 4 pages. After 2 pages the cost is \$.25 per page. All copies will be transmitted to the e-mail address you provide to us. You will need to pre pay for the copies by Money Order or Cashiers Check – no personal checks accepted.

“Certified Copies” are \$5.00 for the first page of each document –per case number, PLUS \$1.00 for each additional page of each document in that same case number. (Example: If your Child Support Order - one document- is 3 pages and the Decree - one document- is 6 pages it would cost: \$7.00 & \$10.00 respectively)

“Exemplified Copies” (also called “Authenticated Copies”) are 7.00 for the first page of each document – per case number, PLUS \$2.00 for each additional page of each document in that same case number. (Example: If your Findings Of Fact - one document- is 5 pages and the Decree – one document- is 3 pages it would cost: \$15.00 & \$11.00 respectively). **If you are picking “Exemplified Copies” up in person, you MUST telephone the Clerk’s Office 8 hours ahead of time, and arrange for these to be made. These take additional time to acquire a Judges’ signature.**

Request copies by E-mail

Due to the large volume of requests receive; please allow 48 hours for a response to your E-mail. We attempt to process these requests daily, however we are not always able to complete all the requests received in one working day.

(In your request for copies, please list your: CASE NUMBER, your NAME(s) at the time the matter was pending in Court, and the TITLE of the documents you want. You will also

need to indicate if you want “Photocopies” or “ Certified Copies.”)

If you will be mailing payment to our office, please submit:

- A Postage Paid, Self-Addressed envelope large enough to contain copies you are requesting. (5-6 pages fit in a ‘legal size’ envelope, than 7 pages, a 12” x 14” envelope).
- A Cashiers Check or a Money Order payable to the Yakima County Clerk for the amount of the copies.)
- A print-out of your e-mail request (which will contain your CASE NUMBER, your NAME(s) at the time the matter was pending in Court, and the TITLE of the documents you want.)
