Driving DIRECTIONS to the Yakima County Courthouse ~ Seattle / Portland / Tri-Cities / Spokane

From SEATTLE: (3.0 hours driving time from Safeco Field)

Take I-90 EAST to Ellensburg.

Take I-82 SOUTH to Yakima / Tri Cities.

Exit the freeway RIGHT at EXIT 31A/B.

(move to the far right lane as you go over the bridges – the exit turns into 2 lanes called “North 1ST Street”. Keep LEFT –Exit 31A- at the fork in the ramp –going straight ahead, do not turn.)

Proceed on North 1st Street –going South-

Turn LEFT onto East Martin Luther King Blvd.

The Courthouse is on the corner to your right.

Turn Right onto North 2nd Street and go around the block to find 2 hour parking on the street, or for a map of public parking areas close to the courthouse click [here: MAP.](#)

From PORTLAND Oregon: (3.25 hours driving time from downtown)

Take I-84 EAST to Biggs.

Cross over the Columbia River to the Washington side and go toward Goldendale. At Goldendale, you should be on **Highway 97 –North-** to Toppenish.

At Toppenish, you may take HWY 97 North to Yakima, *OR* proceed straight until you reach the freeway on ramp for I-82 North to Yakima.

(HWY 97 will merge onto I-82 North.)

Take EXIT 33 / Yakima Avenue. Stay to the LEFT when the exit forks.

Proceed straight on Yakima Avenue to the 6th stop light.

Turn RIGHT onto North 1st Street. Proceed 2 blocks.

Turn RIGHT onto East Martin Luther King Blvd.

The Courthouse is on the corner to your right.

Turn Right onto North 2nd Street and go around the block to find 2 hour parking on the street, or for a map of public parking areas close to the courthouse click [here: MAP.](#)

From the TRI-CITIES: (1.75 hours driving time from Richland)

Take I-82 WEST to Yakima / Pendleton.

Merge onto US-12 WEST (also called I-82 West).

Take EXIT 33 / Yakima Avenue. Stay to the LEFT when the exit forks.

Proceed straight on Yakima Avenue to the 6th stop light.

Turn RIGHT onto North 1st Street. Proceed 2 blocks.

Turn RIGHT onto East Martin Luther King Blvd.

The Courthouse is on the corner to your right.

Turn Right onto North 2nd Street and go around the block to find 2 hour parking on the street, or for a map of public parking areas close to the courthouse click [here: MAP.](#)

From SPOKANE: (3.0 hours driving time from downtown)

Take I-90 WEST to Moses Lake / Ellensburg.

At Ellensburg, take EXIT 110. This will be I-82 SOUTH to Yakima / Tri Cities.

Exit the freeway RIGHT at EXIT 31A/B.

(move to the far right lane as you go over the bridges – the exit turns into 2 lanes called “North 1ST Street”. Keep LEFT –Exit 31A- at the fork in the ramp –going straight ahead, do not turn.)

Proceed on North 1st Street –going South-

Turn LEFT onto East Martin Luther King Blvd.

The Courthouse is on the corner to your right.

Turn Right onto North 2nd Street and go around the block to find 2 hour parking on the street, or for a map of public parking areas close to the courthouse click [here: MAP.](#)
