

**AUDITOR'S CERTIFICATE OF SPECIAL ELECTION  
WAPATO SCHOOL DISTRICT NO. 207  
YAKIMA COUNTY, WASHINGTON**

I, Doug Cochran, Auditor, Yakima County, Washington, and ex-officio Supervisor of Elections, do hereby certify that a special election was held in the Wapato School District No. 207, Yakima County, Washington, on the 26th day of March, 1996, for the purpose of deciding upon the proposition hereinafter set forth, and the results of said election were as indicated following the proposition:

PROPOSITION:

GENERAL OPERATING EXPENSES LEVY

Shall property taxes in excess of statutory and constitutional limitations be levied and collected over a two year period of time in order to provide for the general operating expenses of Wapato School District No. 207, said levies to be \$325,000 in excess taxes (approximately \$.94 per thousand dollars of assessed valuation) for collection in 1997, and \$325,000 in excess taxes (approximately \$.93 per thousand dollars of assessed valuation) for collection in 1998?

The ballots cast at the aforesaid election relative to the proposition were as follows:




