Thank you for your application for the Yakima County ARPA Funding.

Given the enormous importance and impact of these funds, Yakima County has contracted with Clifton Larsen Allen (CLA) to review all applications in their entirety to fully vet eligibility. You may be contacted to provide additional clarifying information, by either CLA or the Yakima County Financial Services Office in the near future. CLA will add an independent review of the applications and will help to make sure the grant awards meet the regulations prescribed by the US Treasury.

As this is an enormous undertaking to review more than 150 applications for compliance with the US Treasury Final Rules for these ARPA funds, the Board of Yakima County Commissioners has made the difficult decision to extend the deadline to award grants until such a time that CLA can complete the review of the applications. We will be making another announcement as to when they expect to award grants to the recipients for the 2022 year, but unfortunately, are not able to commit to a date until CLA completes their role in this process.
