

Describe Fiscal Impact:  
By accepting project as complete, Yakima County will release retainage in the amount of \$6,504.40.

Background Information:  
The Sundome Scoreboard Project was a part of a series of maintenance and improvement projects to be performed throughout State Fair Park facilities in 2020 and 2021. This series of projects will be funded by bond proceeds as part of a capital investment in State Fair Park including ADA, structural, electrical, lighting, roofing, bleachers, HVAC, paint, and restroom upgrades.

Summary & Recommendation:  
Upon approval of project completion, Notice of Completion paperwork will be filed with L&I, Department of Revenue, and the Employment Security Department. Once approval has been received from the three entities, retainage will be released to Pacific Mobile Structures.
