**WHEREAS**, Yakima County by Resolution 14-2012 (Jan. 10, 2012) opted into the Voluntary Stewardship Program (VSP) when Washington State funding was provided; **and**,

**WHEREAS**, the County has received written notice from the Washington State Conservation Commission (WSCC) in a letter dated May 26, 2021, that continued funding is available for the VSP for the 2021 – 2023 Biennium; **and**,

**WHEREAS**, VSP grant funding was provided through the Washington State Conservation Commission (WSCC) for the 2021-23 Biennium and was accepted by the Board of Yakima County Commissioners (BOCC) through Resolution 169-2021 (July 6, 2021); **and**,

**WHEREAS**, the VSP Work Plan is implemented by the local Conservation Districts (North Yakima and South Yakima Conservation Districts). Under this agreement the South Yakima Conservation District (SYCD), as a Technical Service Provider in their District will educate, facilitate, and implement conservation practices with willing land owners implementing the VSP Work Plan; **and**,

**WHEREAS**, Yakima County administers the VSP grant funds from the WSCC and will as identified in the ILA distribute grant funds to the SYCD for work performed under the VSP Work Plan; **and**,

**WHEREAS**, the South Yakima Conservation District has reviewed and signed the ILA with Yakima County to implement the VSP in their District; **now, therefore**,

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners approve the signing of the ILA with the SYCD.
