AMENDMENT NO. 2
TO
DVA CONTRACT NO. 305V-19-064

DVA Contract/Agreement No. 305V-19-064 by and between the Washington State Department of Veterans Affairs ("WDVA") and Yakima County Veterans Program ("Site/College/University"), is amended as follows:

1. Period of Performance

Section IV. PERIOD OF PERFORMANCE is revised to change the end date of the contract from August 31, 2021 to August 31, 2022.

Upon the expiration of this Amendment the Agreement may be renewed for one additional one (1) year period, only upon successful selection to receive a Vet Corps representative for the next academic school year.

The service year period for the Vet Corps Representative to participate and provide services for the Site/College/University is from September 1, 2021 through August 31, 2022.

Once accepted, either party may give written notice of non-renewal to the other party not less than ninety (90) days prior to the expiration of the initial term or any renewal term then in effect.

2. V. FEES

The WDVA Veterans Conservation Corps requires a site participation fee for each Vet Corps representative assigned to the Site/College/University. The Site/College/University shall pay site participation fee required per the below table based on the number of Vet Corps representatives assigned.

During the period of performance of September 1, 2019 through June 30, 2020 Site/College/University received one (1) Vet Corps representative. During the period of performance of July 1, 2020 through August 31, 2021 the Site/College/University received one (1) Vet Corps representative. During the period of performance of September 1, 2021 through August 31 2022 Site/College/University is slated to receive one (1) Vet Corps representative.

ALL OTHER TERMS AND CONDITIONS OF THIS CONTRACT REMAIN IN FULL FORCE AND EFFECT.
