PAY PLAN FOR CERTAIN ELECTED OFFICIALS**

WHEREAS, Article XXX of the Washington State Constitution provides that the compensation of all elective and appointive state, county, and municipal officers who do not fix their own compensation may be increased during their terms of office and RCW 36.17.020 provides that the county legislative authority is authorized to establish the salaries of the elected officials of the county; **and**,

WHEREAS, the Board of Yakima County Commissioners has determined that the salaries of the Assessor, Auditor, Clerk, Treasurer, Coroner, shall be increased effective September 1, 2021, to be in alignment with Board of County Commissioners salary as set forth in Exhibit "A", which is attached hereto and incorporated herein as reference. The salary of the Sheriff shall increase effective September 1, 2021, as set forth in Exhibit "A" which is attached hereto and incorporated herein as reference; **and**,

WHEREAS, the Board of Yakima County Commissioners has further determined that the salaries of the Assessor, Auditor, Clerk, Treasurer, Coroner, and Sheriff shall be increased by 3% effective April 1, 2022; **now, therefore**,

BE IT HEREBY RESOLVED that, commencing September 1, 2021, the Elected Officials pay plan is adopted as set forth in Exhibit "A", which is attached hereto and incorporated herein as reference; **and, therefore**,

BE IT FURTHER RESOLVED that, commencing April 1, 2022, that the Assessor, Auditor, Clerk, Treasurer, Coroner, and Sheriff, receive a 3% pay increase, **now, therefore**,

BE IT FURTHER RESOLVED by the Board of Yakima County Commissioners that the Human Resources Department, and County Auditor's Office are hereby directed to implement the terms of this resolution.
