**WHEREAS**, Mr. Gilliland claims Yakima County should pay Mr. Chino \$750 -- \$230.78 to replace a FOB key that was misplaced by YSO after Mr. Chino was arrested on December 6, 2020, and \$519.22 in attorney's fees (the "Incident"); **and**,

**WHEREAS**, the Corporate Counsel Division of the Yakima County Prosecuting Attorney's Office has investigated Mr. Chino's claim and recommends settlement of the claim relating to the missing FOB key, without admission of liability by any party, by payment of Two Hundred Thirty Dollars and Seventy-Eight Cents (\$230.78) to Omar Chino, in exchange for a complete settlement and release of all claims relating to the missing FOB key; **now, therefore**,

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners that Yakima County pay Omar Chino Two Hundred Thirty Dollars and Seventy-Eight Cents (\$230.78) to settle the claim relating to the missing FOB key, without admission of liability by any party.

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners that Yakima County denies payment of any requested attorney fees.

**BE IT FURTHER RESOLVED** that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment from Yakima County Fund 520 of Two Hundred Thirty Dollars and Seventy-Eight Cents (\$230.78) to Omar Chino as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
