**WHEREAS**, the Yakima County Engineer has certified that it is necessary to close a portion of Tibbling Road, approximately 20' South of Green Ridge Lane, near 620 Tibbling Road, for the replacement of the irrigation mainline by the Naches-Selah Irrigation District. The road closure dates are approximately January 12, 2022 through January 14, 2022 and shall remain in place until the work is complete and the roadway is restored for travel; **now, therefore,**

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners of Yakima County, Washington that the closure of a portion of Tibbling Road is authorized and approved, and the roadway shall remain closed until the necessary construction has been completed.

**BE IT FURTHER RESOLVED** that Naches-Selah Irrigation District is to provide, install, and maintain sufficient traffic control devices, including barricades at all times. All traffic control devices shall comply with the latest published Manual on Uniform Traffic Control Devices for Streets and Highways, by the U.S. Department of Transportation, Federal Highway Administration, with modifications by the Washington State Department of Transportation, as adopted by the Secretary of Transportation. Notices of closures shall be posted at each point of closure.

**BE IT FURTHER RESOLVED** that the Clerk of the Board shall post and publish a notice of said closure in the advertisement section of the local newspaper at least 3 days prior to the closure.

Notice is hereby given that the Board of County Commissioners of Yakima County, Washington, did pass a resolution authorizing the temporary closure of a portion of Tibbling Road, approximately 20' South of Green Ridge Lane, near 620 Tibbling Road. This road closure is for the replacement of the irrigation mainline by the Naches-Selah Irrigation District.

Tibbling Road will be closed to through traffic near 620 Tibbling Road. Local access will be provided to property owners within the closure area, and public access to Yakima County Fire District and School District facilities. The temporary road closure dates are approximately January 12, 2022 through January 14, 2022 and shall remain in place until the work is complete and the roadway is restored for travel.
