

**WHEREAS**, the County Engineer has had plans, specifications and an estimate of costs prepared for demolishing the existing structures and landscaping on two adjacent parcels, which were recently purchased by the County, which the project has been designated Yakima County Project MP 3752 County Shop – House Demolition Project; **now, therefore**,

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners of Yakima County, Washington that the Chairman of the Board is authorized to approve the plans and specifications for constructing the aforesaid portions of the County Shop - House Demolition Project as prepared by the County Engineer for contract.

**BE IT FURTHER RESOLVED** that County Roads is directed to send a “Notice to Bidders” to a minimum of five contractors listed on the MRSC Small Works Roster as being capable of performing this work.
