WHEREAS, pursuant to R.C.W. 36.34.010, Yakima County has the authority to sell its property, whether real, personal, or mixed, providing it is in the best interest of the County; **and**,

WHEREAS, R.C.W. 39.99.020, provides that whenever the county legislative authority desires to dispose of any county property valued less than fifty thousand dollars, that a notice of public hearing is unnecessary; **and**,

WHEREAS, R.C.W. 36.34.130 states that the Board of County Commissioners of Yakima County, Washington may dispose of acquired property to/from another governmental agency, **and**,

WHEREAS, the value of vehicle 60733 -2015 Ford Taurus Vin#1FAHP2MK3FG100847 is \$3,900 and vehicle 60742 Ford Explorer 2015 Vin#1FM5K8AR8FGC67815 is \$2,800.

WHEREAS, the Board of Yakima County Commissioners hereby finds that the value of the property listed is less than fifty thousand dollars; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners find it in the best interest of Yakima County to declare assets 60733 and 60742 as surplus property, and approve the sale to the City of Mabton Police Department.
