WHEREAS, the Board of Yakima County Commissioners has been notified by the Yakima County Environmental Services Director a waterline in the Terrace Heights Water System failed; **and**,

WHEREAS, as a result, significant water damage can occur to public infrastructure, homes and businesses; **and**,

WHEREAS, the Director of Public Services determined that the failure of the waterline constituted an emergency circumstance; **and**,

WHEREAS, there may be times when the Board may lack a quorum or encounter special circumstances on any particular day set as the regular meeting day, or that day may fall on a holiday requiring rescheduling of the regular public meeting; **now, therefore**,

BE IT HEREBY DECLARED AND RESOLVED BY THE BOARD OF YAKIMA COUNTY COMMISSIONERS THAT;

1. The Board of County Commissioners declares that the situation is an emergency necessitating that Yakima County take immediate action to mitigate damage to property and to protect the lives of the citizens of Yakima County.
2. The emergency necessitates the utilization of emergency powers granted pursuant to RCW 36.32.270 and RCW 39.04.280, which allow streamlined processes for purchasing goods and services.
3. The Director of Yakima County Public Services is authorized to enter into contracts and obligations for goods and services necessary to respond to the declared emergency to protect the health, welfare, and property of the citizens of Yakima County and to provide the citizens with emergency assistance.
