

WHEREAS, Ms. Martinez claims Yakima County should reimburse her \$26.89 for the cost of books she sent to an inmate. However, the inmate did not receive them. (the "Incident"); **and**,

WHEREAS, the Corporate Counsel Division of the Yakima County Prosecuting Attorney's Office has investigated Ms. Martinez's claim and recommends settlement of all claims relating to the Incident, without admission of liability by any party, by payment of the settlement amount of Twenty-Six Dollars and Eighty-Nine Cents (\$26.89) to Amanda Martinez, in exchange for a complete settlement and release of all claims relating to the Incident; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that Yakima County pay Amanda Martinez Twenty-Six Dollars and Eighty-Nine Cents (\$26.89) to settle all claims relating to the Incident, without admission of liability by any party.

BE IT FURTHER RESOLVED that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment from Yakima County Fund 520 of Twenty-Six Dollars and Eighty-Nine Cents (\$26.89) to Amanda Martinez as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
