**WHEREAS**, Mr. Powell claims Yakima County should pay him \$332.18 to cover the cost of replacing his rear, driver’s side window after it was damaged on June 12, 2022; **and**,

**WHEREAS**, the Corporate Counsel Division of the Yakima County Prosecuting Attorney’s Office has investigated Mr. Powell’s claim and recommends settlement of all claims relating to the Incident, without admission of liability by any party, by payment of Three Hundred Thirty-Two Dollars and Eighteen Cents (\$332.18) to Bryan Powell, in exchange for a complete settlement and release of all claims relating to the Incident; **and**,

**BE IT HEREBY RESOLVED**, by the Board of Yakima County Commissioners that Yakima County pay Bryan Powell, Three Hundred Thirty-Two Dollars and Eighteen Cents (\$332.18) to settle all claims relating to the Incident, without admission of liability by any party; **now, therefore**,

**BE IT FURTHER RESOLVED** that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment from Yakima County Fund 520 of Three Hundred Thirty-Two Dollars and Eighteen Cents (\$332.18) to Bryan Powell as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
