WHEREAS, Mr. Ramirez claims Yakima County should pay him \$454 to replace his cell phone and wallet that were mistakenly given to another inmate when that inmate was released from the Department of Corrections on July 1, 2022 (the “Incident”); **and**,

WHEREAS, the Corporate Counsel Division of the Yakima County Prosecuting Attorney’s Office has investigated Mr. Ramirez’s claim and recommends settlement of all claims relating to the Incident, without admission of liability by any party, by payment of the settlement amount of Four Hundred Fifty-Four Dollars (\$454) to Martin Ramirez, in exchange for a complete settlement and release of all claims relating to the Incident; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that Yakima County pay Martin Ramirez Four Hundred Fifty-Four Dollars (\$454) to settle all claims relating to the Incident, without admission of liability by any party.

BE IT FURTHER RESOLVED that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment from Yakima County Fund 520 of Four Hundred Fifty-Four Dollars (\$454) to Martin Ramirez as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
