**WHEREAS**, Mr. Willsey claims Yakima County should pay to repair their company's pickup after it was backed into by a county road grader on July 11, 2022; **and**,

**WHEREAS**, the Corporate Counsel Division of the Yakima County Prosecuting Attorney's Office has investigated Mr. Willsey's claim and recommends settlement of all claims relating to the Incident, without admission of liability by any party, by payment of Five Thousand Sixty-Three Dollars and Seventy-Four Cents (\$5,063.74) to Red Willow Vineyard and Two Hundred Fifty-Nine Dollars and Fifty-Three Cents (\$259.53) to Frontier Adjuster in exchange for a complete settlement and release of all claims relating to the Incident; **and**,

**WHEREAS**, the Washington Counties Risk Pool (WCRP), subject to reimbursement by Yakima County, will prepare and deliver payment of Five Thousand Sixty-Three Dollars and Seventy-Four Cents (\$5,063.74) to Red Willow Vineyard and Two Hundred Fifty-Nine Dollars and Fifty-Three Cents (\$259.53) to Frontier Adjuster as settlement of this claim; **now therefore**,

**BE IT HEREBY RESOLVED**, by the Board of Yakima County Commissioners that Yakima County pay Red Willow Vineyard, Five Thousand Sixty-Three Dollars and Seventy-Four Cents (\$5,063.74) and Frontier Adjusters Two Hundred Fifty-Nine Dollars and Fifty-Three Cents (\$259.53) to settle all claims relating to the Incident, without admission of liability by any party; **now, therefore**,

**BE IT FURTHER RESOLVED** that the Prosecuting Attorney's Office, Corporate Counsel is authorized and directed to provide a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson so that he may arrange for payment from Yakima County Fund 520 of a total of Five Thousand Three Hundred Twenty-Three Dollars and Twenty-Seven Cents (\$5,323.27) to reimburse the Washington Counties Risk Pool for the settlement payment. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
