

**WHEREAS**, it has come to the attention of the Board that a request for sole source purchase of a K9 Officer (Dog) from Blue Line K9 LLC is justified and necessary; **and**,

**WHEREAS**, Blue Line K9 LLC is the only provider of the specialized K9 Dogs that are raised and socialized in a unique home environment, come with a minimum of basic obedience, protection bite work and are advanced in their human tracking abilities; **now, therefore**,


**STATEMENT OF NEED:**
