**BOARD OF YAKIMA COUNTY COMMISSIONERS

**IN THE MATTER OF PERMITTING  
THE TEMPORARY OPERATION OF  
SNOWMOBILES ON PORTIONS OF  
OLD RIVER ROAD, BUMPING RIVER  
ROAD, TIETON RESERVOIR ROAD,  
NORTH FORK ROAD, AND NILE ROAD**

**WHEREAS**, pursuant to Yakima County Code 9.46, the Board of County Commissioners of Yakima County, Washington may open certain County roads to wintertime snowmobile traffic concurrently with motor vehicle traffic; **and**,

**WHEREAS**, it has been brought to the attention of the Board that there is public interest and support for permitting the operation of snowmobiles on certain County roads; **and**,

**WHEREAS**, the County Engineer recommends that the safe operating speed for all vehicles to be twenty-five miles per hour on all portions of Yakima County roads designated by resolution as open to snowmobile traffic concurrently with motor vehicles; **now, therefore**,

**BE IT HEREBY RESOLVED** that the Board of Yakima County Commissioners does hereby designate that the following portions of Yakima County roadways be open to snowmobile traffic concurrently with motor vehicles:

A portion of **Old River Road**, Road Log No. 16050, from M.P. 0.01 (near SR 410 intersection) to M.P. 1.02 (Forest Road No. 311 - Lost Creek Road).

A portion of **Bumping River Road**, Road Log No. 10500, from M.P. 7.95 (Private Road - Snow Goose Lane in Goose Prairie Area) and continuing to M.P. 10.97 (end of the County Road).

A portion of **Tieton Reservoir Road**, Road Log No. 20060, from M.P. 10.60 (Forest Road No. 718) to M.P. 13.70 (Forest Road No. 590).

A portion of **North Fork Road**, Road Log No. 30000, from M.P. 8.84 (east of Ahtanum Meadows) to M.P. 9.54 (end of county road).

A portion of **Nile Road**, Road Log No. 15550, from M.P. 1.33 (Forest Road No. 1500 - Bethel Ridge Road) to M.P. 3.19 (Forest Road No. 1600 - Clover Springs Road).

**BE IT FURTHER RESOLVED** that the County Engineer is directed to post the appropriate signing to delineate the dual usage portions and speed limit signs for Old River Road, Bumping River Road, Tieton Reservoir Road, North Fork Road, and Nile Road when conditions are appropriate for snowmobile use.

**BE IT FURTHER RESOLVED** that the board of County Commissioners of Yakima County, Washington, designates the aforesaid portions of Yakima County roadways be open to snowmobile traffic concurrently with motor vehicles to be effective November 15<sup>th</sup>, 2022, or from the time when weather allows the use of snowmobiles, whichever comes last, until April 1, 2023
