ARTICLE 31 – WORK IN HIGHER CLASSIFICATION

This Memorandum of Agreement shall amend the 2022-2024 Collective Bargaining agreement to reflect a change in Article 31 – Work in Higher Classification as shown below.

- 31.1 An employee who is assigned work in a higher classification than he/she is normally assigned shall be compensated at the base rate plus premium pays of the appropriate level for the assigned position. Persons assigned to work at such positions should be from a list of eligible employees for promotion to that classification. In either case the employee will be paid at the higher classification once the employee has worked within that classification for a minimum of one (1) hour


