**293 - 2022**

**WHEREAS**, the Yakima County Engineer has certified that it is necessary to close a portion of Guinan Road, from the intersection with Speyers Road for 2,900 feet to the West, for the installation of two new 36" HDPE pipes to replace the existing pipe crossing. The road closure will be for approximately 2 to 3 days between December 15, 2022 and December 22, 2022, and shall remain in place until the work is complete and the roadway is restored for travel; **now, therefore,**

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners of Yakima County, Washington that the closure of a portion of Guinan Road is authorized and approved, and the roadway shall remain closed until the necessary construction has been completed.

**BE IT FURTHER RESOLVED** that Naches-Selah Irrigation District to provide, install, and maintain sufficient traffic control devices, including barricades at all times. All traffic control devices shall comply with the latest published Manual on Uniform Traffic Control Devices for Streets and Highways, by the U.S. Department of Transportation, Federal Highway Administration, with modifications by the Washington State Department of Transportation, as adopted by the Secretary of Transportation. Notices of closures shall be posted at each point of closure.

**BE IT FURTHER RESOLVED** that the Clerk of the Board shall post and publish a notice of said closure in the advertisement section of the local newspaper at least 3 days prior to the closure.

**Temporary Closure of a portion of Guinan Road**

Notice is hereby given that the Board of County Commissioners of Yakima County, Washington, did pass a resolution authorizing the temporary closure of a portion of Guinan Road, from the intersection with Speyers Road for 2,900 feet to the West. This road closure is for the replacement of the pipe crossing by Naches-Selah Irrigation District.

Guinan Road will be closed to through traffic from Speyers Road for 2900' to the West. Local access will be provided to property owners within the closure area, and public access to Yakima County Fire District and School District facilities. The temporary road closure will be for approximately 2-3 days between December 15, 2022 and December 22, 2022, and shall remain in place until the work is complete and the roadway is restored for travel.
