**WHEREAS**, Athan Papailiou of the Law Office of Athan Papailiou represents former employee Tamara Colley who asserted various allegations of discrimination and retaliation; **and**,

**WHEREAS**, the Corporate Counsel Division of the Yakima County Prosecuting Attorney's Office recommends settling the matter under terms and conditions mutually acceptable between the parties and without admission of liability by any party in exchange for a written settlement of all claims and a complete release of any alleged or potential claims; **and**,

**BE IT HEREBY RESOLVED** that the Clerk of the Board is authorized and directed to provide a copy of this resolution to the Yakima County Auditor's Office so that Auditor Ross may arrange for payment from Yakima County of a total of eighteen thousand, six hundred sixty-four dollars (\$18,664) less applicable payroll withholdings, to Mr. Papailiou on behalf of Ms. Colley.

**BE IT FURTHER RESOLVED** that Yakima County is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
