

**WHEREAS**, Resolution No. 140-2019 established a Municipal Research and Services Center of Washington (MRSC) Small Works Roster for Yakima County Department of Public Works projects with an estimated value of three hundred thousand dollars or less; **and**,

**WHEREAS**, the HOME Administrator determined that a project involving an owner or tenant occupied housing unit, is eligible for the HOME Rehab Loan Program at **712 S. 5th St., Sunnyside, WA 98944, Project No. HM18-010** qualifies to be completed by the MRSC Small Works Roster process, rather than the competitive bidding process set forth in RCW 36.32.250; **and**,

**WHEREAS**, the HOME Administrator had plans, specifications, and an estimate of cost prepared for rehabilitation of the aforesaid improvements; **and**,

**WHEREAS**, 34 contractors listed on the Municipal Research and Services Center of Washington (MRSC) Small Works Roster were invited to submit bids for the aforesaid work, bid opening was set for December 23, 2019 at 10:00 AM or as soon thereafter as possible at the Yakima County Courthouse, Public Services Department, 4th floor, 128 N. 2<sup>nd</sup> St., Yakima, WA 98901 as noted in the Notice of Bid Proposal; **and**,
