**2023 MEMORANDUM OF UNDERSTANDING AND AGREEMENT  
SOLID WASTE**

This Memorandum of Understanding and Agreement, between the Yakima Health District (Health District) and Yakima County (County) is created to satisfy the requirements of RCW 70.95.160 whereas the local Health District is tasked to assist the County in the implementation of its comprehensive solid waste management plan. This Memorandum of Understanding and Agreement consists of:

1. Funding for the Health District's assistance to the County in the implementation of the solid waste management plan under RCW 70.95.160; and
2. Compensation to the Health District for preparation and issuance of the necessary permits and regulatory oversight for all Yakima County operated solid waste facilities and activities.


In lieu of a solid waste permit fee, the County will pay the Health District in the amount of \$5,000.00 per month. The Health District will bill the County monthly.

The Health District will provide summarized quarterly and yearly reports upon request to the County showing the number of complaints received, the abatement status, and the Health District time utilized to provide the services. It is anticipated that the reports will be available within 90 days after the quarter ends.

This Memorandum of Understanding and Agreement is for calendar year 2023. The reimbursement levels are valid for only that year. In subsequent years, the reimbursement level may be negotiated.

This Agreement may be terminated by either the Yakima County Health District or Yakima County. To terminate, a ninety (90) day written notice of "Intent to Terminate" must be given to the other party prior to the start of each year. If the contract is terminated, the County will compensate the District for that portion of services extended to the time of termination.
