Background Information:





INTERLOCAL AGREEMENT BETWEEN THE CITY OF SUNNYSIDE, WASHINGTON
AND THE YAKIMA SHERIFF'S OFFICE, WASHINGTON, FOR THE HOUSING OF INMATES

ADDENDUM III

THIS ADDENDUM TO OUR INTERLOCAL AGREEMENT (hereinafter referred to as "Agreement") is made and entered into by and between the City of Sunnyside, Washington and the Yakima Sheriff's Office, Washington;

WHEREAS, the City of Sunnyside and the Yakima Sheriff's Office already have an Agreement for the housing of inmates;

WHEREAS, the City of Sunnyside desires to modify this Agreement;

NOW THEREFORE, in consideration of the mutual covenants, condition and promises contained herein, the parties hereto mutually agree as follows:

SECTION 6(a) COMPENSATION shall be repealed and replaced with:

(a) Rates. Sunnyside agrees to accept and house Yakima Sheriff's Office inmates for compensation per inmate at the rate of \$80.00 per day. The date of booking into the Sunnyside Jail of any Yakima Sheriff's Office inmate shall be charged a minimum of a full daily rate per inmate regardless of the time of booking within a 24 hour period. The date of release from the Sunnyside Jail and/or returned to Yakima Sheriff's Office, regardless of the time frame within a 24 hour day shall not constitute a charge by the City of Sunnyside against Yakima Sheriff's Office.

This Agreement shall be effective from February 1, 2023 or once fully endorsed by both parties, whichever is latter.

The remainder of the original Agreement remains unchanged.
