**WHEREAS**, pursuant to R.C.W. 36.34.010, Yakima County has the authority to sell its property, whether real, personal, or mixed, providing it is in the best interest of the County; **and**,

**WHEREAS**, R.C.W. 39.33.020, provides that whenever the county legislative authority desires to dispose of any county property value of which is less than fifty thousand dollars, that a notice of public hearing is unnecessary; **and**,

**WHEREAS**, the Board of Yakima County Commissioners hereby finds that the value of the property listed in "Exhibit A" is less than fifty thousand dollars; **now, therefore**,

**BE IT HEREBY RESOLVED** by the Board of Yakima County Commissioners the following determination has been reached:

That it is in the best interest of Yakima County to declare the property described in "Exhibit A" as surplus to the needs of the County and direct the Yakima County Equipment Rental & Revolving Fund Agent to dispose of such property by sale or by such other legal means as the Equipment Rental & Revolving Fund Agent determines is in the best financial interest of the County.

**BE IT FURTHER RESOLVED** that the Clerk of the Board of Yakima County Commissioners shall cause the Findings and Determination to be spread upon its minutes and made a matter of record.
