DISTRIBUTION OF PUBLIC UTILITIES
PRIVILEGE TAXES FOR 2022**

WHEREAS, the State of Washington levies and collects from every public utilities district a tax for the privilege of engaging within this state in the business of operating works, plants or facilities for the generation, distribution and sale of electric energy; **and**,

WHEREAS, pursuant to RCW 54.28.050, the Yakima County Treasurer has received from the Washington State Department of Revenue tax proceeds from non-nuclear generating facilities for distribution in the amount of \$111,649.61; **and**,

WHEREAS, pursuant to RCW 54.28.055, the Yakima County Treasurer has also received from the Washington State Department of Revenue tax proceeds from thermal electric-generating facilities for distribution in the amount of \$83,968.67; **and**

WHEREAS, the Board of Yakima County Commissioners has the authority to direct the County Treasurer to deposit funds according to the manner they deem equitable; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that the County Treasurer is directed to deposit the sum of \$195,618.28 to the Yakima County General Fund.
