

WHEREAS, United States Code, Title 16, Section 715s, provides for revenue sharing to local governments as payment in lieu of taxes for the National Wildlife Refuge System; **and**,

WHEREAS, the sum of \$7,130.00 was received by Yakima County Treasurer for the Fiscal Year 2022 revenue sharing payment for the Toppenish Wildlife Refuge; **and**,

WHEREAS, Title 16, Section 715s, provides for the distribution of those funds on a proportional basis to those units of local government which have incurred loss or reduction of real property tax revenues by reason of the existence of such wildlife refuge, **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that the amount of \$7,130.00 be distributed to local governments affected by the Toppenish Wildlife Refuge as provided within United States Code as follows:
