

**WHEREAS**, Mr. Weippert claims Yakima County should pay him \$2,475.09 as reimbursement for Pacific Power invoices he has been paying (“the incident”); and

**WHEREAS**, the Corporate Counsel Division of the Yakima County Prosecuting Attorney’s Office has investigated Mr. Weippert’s claim and recommends settlement of all claims relating to the Incident, without admission of liability by any party, by payment of the settlement amount of Two Thousand Four Hundred Seventy-Five Dollars and Nine Cents (\$2,475.09) to Don Weippert, in exchange for a complete settlement and release of all claims relating to the Incident; **now, therefore**

**BE IT HEREBY RESOLVED**, that Yakima County pay Mr. Weippert Two Thousand Four Hundred Seventy-Five Dollars and Nine Cents (\$2,475.09) to settle all claims relating to the Incident, without admission of liability by any party.

**BE IT FURTHER RESOLVED** that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment of Two Thousand Four Hundred Seventy-Five Dollars and Nine Cents (\$2,475.09) to Don Weippert as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
