WHEREAS, the Board of County Commissioners of Yakima County, Washington, did pass Resolution No. 59-2023, approving the Independence Road Improvement Project for contract; **and**,

WHEREAS, the Board of County Commissioners executed the contract with American Rock Products, for the Independence Road Improvement Project; **and**,

WHEREAS, it is the recommendation of the County Engineer of Yakima County, to temporarily close a section of Independence Road from North Outlook Road to Maple Grove Road in order to facilitate a bridge replacement; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners by the Board of County Commissioners of Yakima County, Washington that the portion of Independence Road, from North Outlook Road to Maple Grove Road, be closed to through traffic from July 10th through July 14th, or until the bridge has been restored.

BE IT FURTHER RESOLVED that the temporarily closed aforesaid portion of Independence Road, from North Outlook Road to Maple Grove Road be posted with detour signage and all other appropriate work zone signage during the closure, as required by law, until the road is reopened to the public.

Temporary closure of a portion of Independence Road

NOTICE is hereby given that the Board of County Commissioners of Yakima County, Washington, did pass a resolution authorizing the temporary closure of a portion of Independence Road, from North Outlook Road to Maple Grove Road, to facilitate a road improvement project.

Independence Rd will be closed through traffic between North Outlook Rd and Maple Grove Rd. Local access will be provided to property owners within the closure, and public access to Yakima County Fire District and School District facilities. The temporary road closure will begin July 10th, 2023, and shall remain in place until July 14th, 2023, or until the work is complete and the roadway is restored for travel.

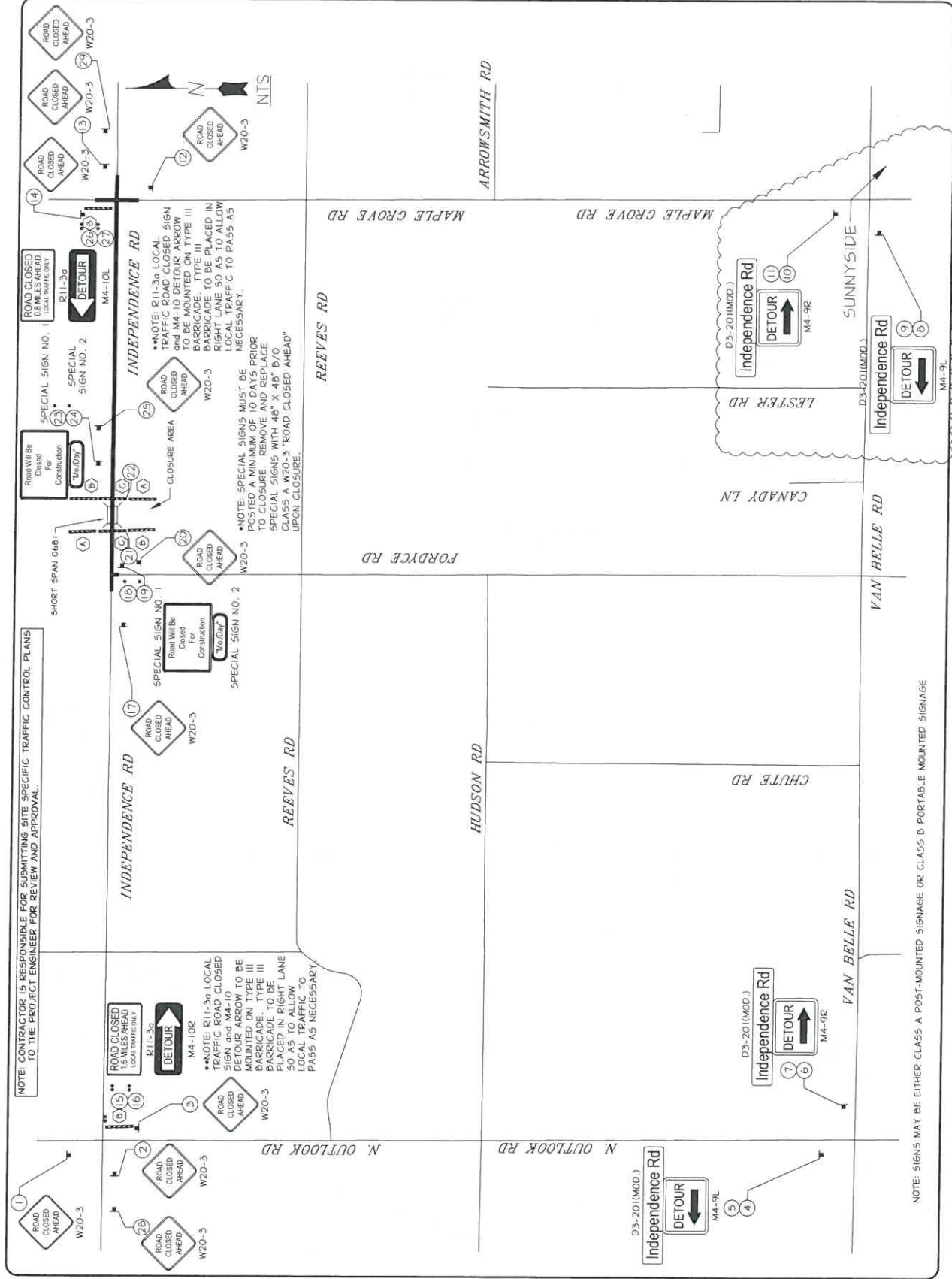
