Background Information:



WHEREAS; R.C.W.39.04.280 provides for exemption from the competitive bidding requirements; **and,**

WHEREAS; competitive bidding requirements may be waived by the governing body of the municipality for purchase that are clearly and legitimately limited to a single source of supplier purchases involving Sole Source; **and,**

WHEREAS; Yakima County Sheriff's office requires continuity of service, including radio maintenance for AVTEC dispatch consoles and two way radio system equipment for 12 months ; **now, and,**

WHEREAS, RACOM has the specialized knowledge to maintain the equipment; **and,**

WHEREAS; a notice of intent to make a sole source purchase from RACOM was passed by resolution 153-2023 and it has come to the attention of the Board that a request for sole source purchase from RACOM is justified and necessary; **now, therefore,**

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that bidding requirement be, and hereby is, waived pursuant R.C.W. 39.04.280 and that RACOM is authorized as a sole source vendor for this purchase.

BE IT FURTHER RESOLVED that Yakima County enters a contract with RACOM for a 12-month period.
