

WHEREAS, the Health Care Authority administers the medical, dental, life, and long term disability insurance coverage for the employees of the state of Washington, as set forth in chapter 41.05 RCW; **and**,

WHEREAS, we deem the state insurance plans as providing desirable insurance coverage for eligible employees and the elected officials of Yakima County; **and**,

WHEREAS, we certify that all employees and elected officials of Yakima County enrolled are eligible to participate in the state insurance plans; **now, therefore**,

BE IT HEREBY RESOLVED, that Yakima County requests approval by the Health Care Authority to participate in the state insurance plans for the eligible employees and elected officials of Yakima County, subject to the requirement of RCW 41.04.205 and the rules adopted thereunder.
