WHEREAS, Mr. Glossip claims Yakima County should pay him \$3,000 to replace an earring that went missing while he was incarcerated at the Yakima County Department of Corrections (YCDOC) (the “Incident”); **and**,

WHEREAS, the Corporate Counsel Division of the Yakima County Prosecuting Attorney’s Office has investigated Mr. Glossip’s claim and recommends settlement of the claim without admission of liability by any party, for the negotiated payment of One Hundred Dollars (\$100) to Nathaniel Glossip, in exchange for a complete settlement and release of all claims relating to the incident; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that Yakima County pay Nathaniel Glossip the negotiated amount of One Hundred Dollars (\$100) to settle the claim relating to the missing earring, without admission of liability by any party.

BE IT FURTHER RESOLVED that the Clerk of the Board is authorized and directed to submit a copy of this resolution to Chief Civil Deputy Prosecuting Attorney Don Anderson to arrange for payment from Yakima County Fund 520 of One Hundred Dollars (\$100) to Nathaniel Glossip as full consideration for a complete settlement and release of all claims relating to the Incident, in such terms and form as is satisfactory to the Yakima County Prosecuting Attorney. The Chief Civil Deputy is further authorized to take whatever actions are reasonable and prudent to conclude the settlement provided by this resolution.
