**WHEREAS**, the County Engineer has commissioned new load ratings for certain County bridges to comply with the Federal Highway Administration's National Bridge Inspection Standards; **and**,

**WHEREAS**, as a result of this effort, the County Engineer has determined certain structures to have weight restrictions placed on them; **now therefore**,

**BE IT HEREBY RESOLVED** by the Board of County Commissioners of Yakima County, Washington, that the Bumping River Road Bridge No. 774 shall be posted for the weight limits determined by the County Engineer until such time as the bridge is rehabilitated to carry a higher loading, or until the structure is replaced.

**BE IT FURTHER RESOLVED** that the County Engineer shall diligently pursue correcting the structural deficiencies in a timely manner and shall pursue all funding sources available to help make the necessary repairs or replacement.

**BE IT FURTHER RESOLVED** that any person violating the posted weight limit posted for the Bumping River Road Bridge No. 774 shall be guilty of a misdemeanor, pursuant to RCW 36.75.270.
