Background Information:



WHEREAS, the Corporate Counsel Division of the Yakima County Prosecuting Attorney's Office investigated Mr. Turner's claim and recommends that his claim be denied; **now; and**,

WHEREAS, the Board of Yakima County Commissioners, having reviewed the facts and circumstances, finds Mr. Turner's claim does not establish a basis for Yakima County to pay him any money; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that Claim No. 12-2020 submitted by Cecil Turner is hereby denied.
