1. CALL TO ORDER

Meeting Called to Order at 10:00 a.m.

PRESENT: Chair LaDon Linde, Commissioner Amanda McKinney, Commissioner Kyle Curtis, Legal Counsel Stefanie Weigand, Clerk of the Board Julie Lawrence, Deputy Clerk of the Board Erin Franklin, and guests.

3. PUBLIC COMMENT

No Public Comment Received.

4. PRESENTATION

Commissioner Linde gave examples of how Yakima County employees make significant contributions to our community each day, and explained that the Board would be highlighting five employees in particular through the "Extra Mile Award" as part of Public Service Appreciation Week.

Marivel Garcia (Public Services): Public Services Director Lisa Freund spoke on Marivel's great work ethic and customer service over 19 years of service, noting that she is also Yakima County's first female Building Official. Lisa explained how Marivel proactively led her division through the pandemic, finding innovative ways to keep business running. She has also fostered a partnership with DSHS, offering opportunities for internships in Public Services; these interns are often disadvantaged youth who are looking to develop job skills, and they provide much-needed support to the department. Presenting Marivel with her award, Environmental Services Director David Haws echoed Lisa's thoughts and confirmed how much Marivel cares about the work she does.

Carolina Herrera (Probation Services): District Court Judge Schweppe spoke about Carolina's service to Yakima County over 28 years, specifically noting a story of her work with a former probation client. He observed that her quality and manner of work demonstrate and embody how the Courts are not meant to be merely punitive, but to offer compassion, empathy, and kindness.

Deborah Clausing (Prosecutor's Office): County Prosecutor Joe Brusich explained that Deborah's work with the County began in 1996 in Human Resources and continued with the Prosecutor's Office in 2019. He shared that Deborah keeps the office running with her competency and skill, and summarized her work by stating, "Without her, I would fail." He praised her integrity, character, kindness, loving nature, work ethic, honesty, accountability, gratitude, and humility, adding that people walk away better because of her.

Officer Robert McGuire (Department of Corrections): DOC Director Jeremy Welch explained how Robert has weathered many changes and challenges throughout his time at DOC with an amazing attitude. He has been part of implementing a new training plan/program, as well as a new peer support program. He has been an incredible support to the department and his fellow employees.

Finally, Commissioner Linde observed that this is also Corrections Officer Recognition Week, and thanked Yakima County's corrections officers for their service to the community.
