

**RESOLUTION TO AWARD HOMELESS
HOUSING AND ASSISTANCE PROGRAM
FUNDS FOR FISCAL YEAR ENDING 2021
AND FISCAL YEAR ENDING 2022**

WHEREAS, Yakima County is the administrative agent for State CHG and Local 2163 funds; **and**,

WHEREAS, the Yakima County Human Services Department published a Housing Homeless and Assistance (HHA) Program Request for Proposals for programs addressing homelessness in alignment with the Yakima County 5-Year Plan; **and**,

WHEREAS, the project types funded were: Coordinated Entry (for both Adults and Young Adults), Outreach, Rental Assistance (both general and Veterans-specific), Housing and Essential Needs, Permanent Supportive Housing, Shelter (24-hour within City of Yakima, Overnight in Lower/Southern Valley, Domestic Violence in Upper and Lower/Southern Valley, Extreme Winter Weather, and Youth and Young Adults), and Capital Improvement; **and**,

WHEREAS, the Yakima County Homeless Coalition Competitive Process Scoring Committee, made up of professionals and community members without conflicts of interest or preexisting ties to applicants, scored the grants based on a rubric provided by the Human Services Department and published prior to scoring; **and**,

WHEREAS, the Yakima County Commissioners are responsible for issuing grants based on the needs of the community, the restrictions and availability of the funding, and the scores of the Competitive Process Scoring Committee; **now, therefore**,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of 24-Hour Low Barrier Overnight Shelter (within the City of Yakima) funding, Rod's House will be awarded \$46,500; Yakima Neighborhood Health Services will be awarded \$75,000; and Triumph Treatment Services will be awarded \$20,000; **and**,

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Youth and Young Adult Shelter funding, Rod's House will be awarded \$125,000; **and**,

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Extreme Winter Weather Shelter funding, Rod's House will be awarded \$55,000; Yakima Neighborhood Health Services will be awarded \$94,070; and ma Valley Farm Workers Clinic DBA Northwest Community Action Center will be awarded \$52,600; **and**,

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Low-Barrier Overnight Shelter (in Lower Valley) funding, Generating Hope will be awarded \$100,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Domestic Violence Shelter (in Upper Valley) funding, YWCA will be awarded \$100,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Domestic Violence Shelter (in Lower Valley) funding, The Lighthouse will be awarded \$46,665; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Capital Improvement funding, Rod's House will be awarded \$200,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Coordinated Entry (Adults) funding, Yakima Neighborhood Health Services will be awarded \$75,000; and Yakima Valley Farm Workers Clinic DBA Northwest Community Action Center will be awarded \$15,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Coordinated Entry (Young Adults) funding, Rod's House will be awarded \$15,000; and Yakima Neighborhood Health Services will be awarded \$10,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Outreach funding, Rod's House will be awarded \$30,000; and Yakima Neighborhood Health Services will be awarded \$58,000; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Permanent Supportive Housing funding, Yakima Neighborhood Health Services will be awarded \$129,768; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Rental Assistance funding, Yakima Neighborhood Health Services will be awarded \$262,000; Yakima Valley Farm Workers Clinic DBA Northwest Community Action Center will be awarded \$390,642; and Catholic Charities Diocese of Yakima will be awarded \$134,239; **and,**

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Rental Assistance (Veterans) funding, Yakima County Veterans Program will be awarded \$16,000; **and,**

**BOARD OF YAKIMA COUNTY COMMISSIONERS

BE IT FURTHER RESOLVED that for the upcoming HHA Grant Cycle starting July 1, 2020 and ending June 30, 2022, in the category of Housing and Essential Needs funding, Yakima Neighborhood Health Services will be awarded \$706,272; and Yakima Valley Farm Workers Clinic DBA Northwest Community Action Center will be awarded \$653,798.


