Presenting: Jase Testerman, County Roads

Jase Testerman stated that County Roads received a request from Mr. Saunders with Apple King to lease a small strip of a parceled portion of the Naches Branch Line that the County acquired during the Rails to Trails program. Mr. Saunders wanted to purchase the property, but since the County acquired it as part of the rail banking process with the trail, we unable to sell and must act as stewards in the event a rail line needs to be put back in. Mr. Saunders has agreed to lease the property.

Commissioner McKinney asked if there would be an impact to the Greenway, as they are currently re-writing their master plan and looking to connect and move further out that direction. Jase does not anticipate any issue as the trail is already in place and has adequate space.
