1. CALL TO ORDER

Meeting Called to Order at 9:00 a.m.

PRESENT: Chair LaDon Linde, Commissioner Amanda McKinney, Commissioner Kyle Curtis, Legal Counsel Don Anderson, Clerk of the Board Julie Lawrence, Planning Official Tommy Carroll, District Court Administrator Therese Murphy, Technology Services Director Dale Panattoni and Guests.

2. PUBLIC COMMENT

Kenton Gartell voiced concern related to agritourism and festival permitting. He believes Public Services Codes department needs to reconsider its approach.

Steve Saunders expressed frustration regarding slow progress in implementing agritourism changes and mentions that some wineries are allowed to host gathering while he faces strict enforcement. He expressed concern regarding current code and its impact on property rights in Yakima County.

3. PANIC BUTTON PROJECT UPDATE (30 Minutes) - Therese Murphy

Therese Murphy and Dale Panattoni gave a presentation regarding a proposed update to Yakima County's panic button system. The Commissioners asked Therese and Dale to bring this item forward for discussion during the November Department Head/Elected Officials Meeting.

4. PUBLIC SERVICES (60 Minutes)

Tommy Carroll and Olivia Story discussed updates to the Agritourism Code. They talked about the need to ensure the safety of RV's used for accommodations, potential liability issues, and how to inspect and permit the RV's. They also mentioned the need for an application process and the importance of protecting public safety. Commissioner McKinney asked to meet with Olivia and Tommy to discuss the code updates and work on proposed language for the RV-related part of the ordinance. The Commissioners agreed to move forward with scheduling a public hearing.
