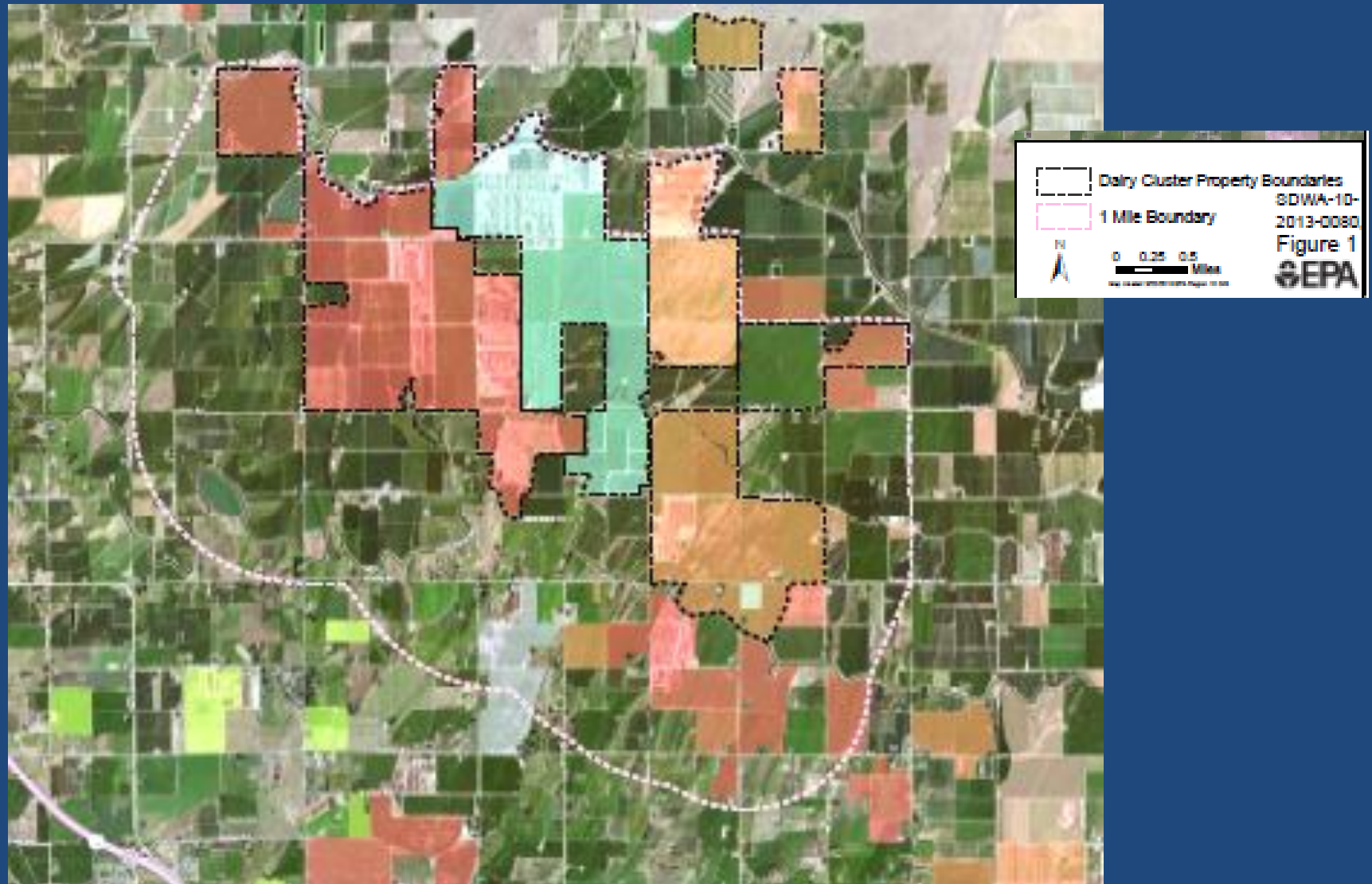

- 2) Monitoring Well establishment and sampling
- 3) Sampling associated with source control

Residential Well Sampling



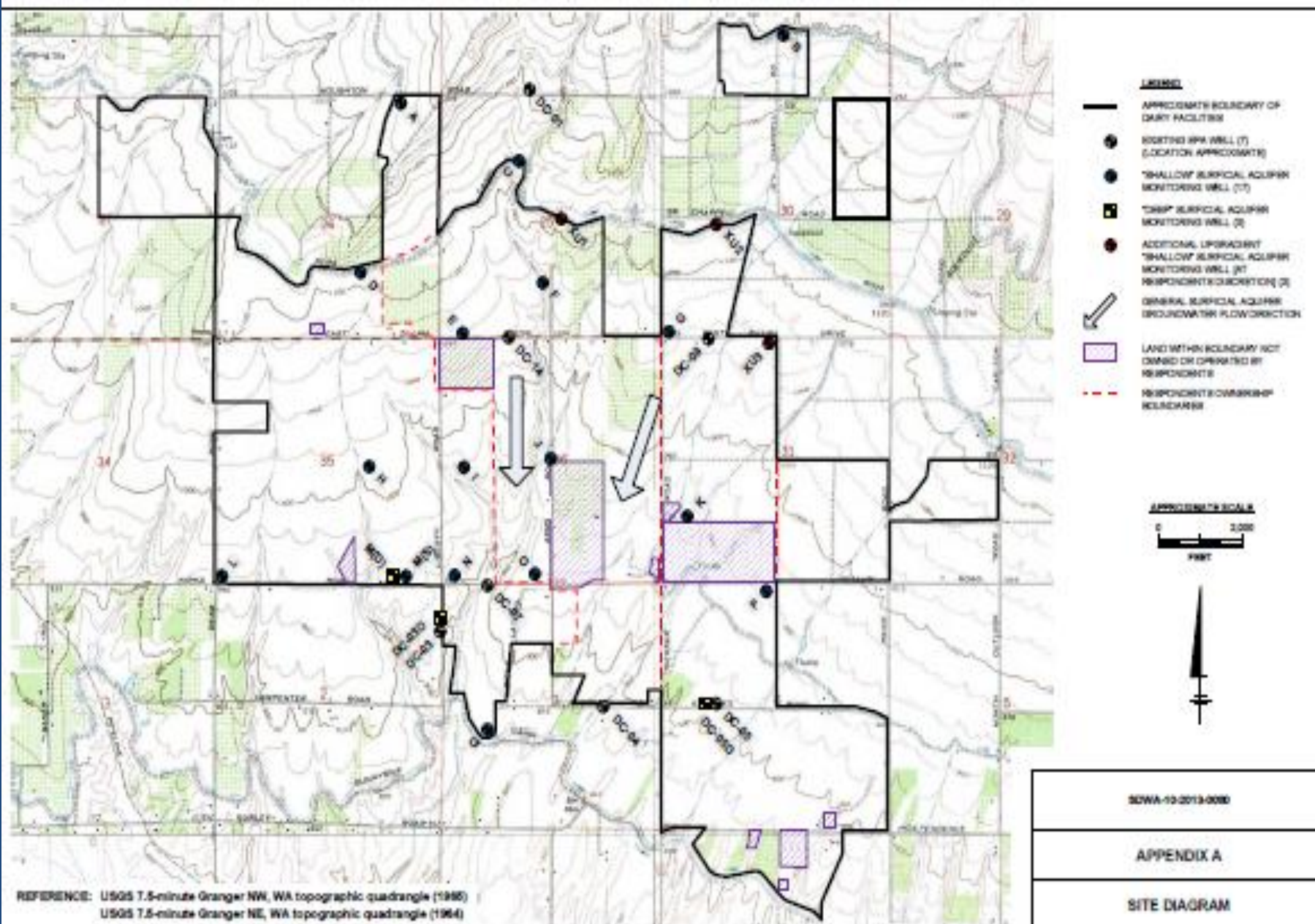
Source Control

Early **source control** actions to reduce nitrate loading to the aquifer

- Soil sampling in application fields and manure testing
- Test lagoons to ensure they meet current state permeability standard
- Irrigation water management – water metering and root-zone sensors
- Assessment of area upgradient of monitoring well with 190 ppm nitrate

Monitoring wells

- 16 wells in addition to EPA's 7 wells = 23 wells
- 3 year review
- 8 years of quarterly monitoring
- Additional source control and monitoring may be required



Overview of Data to be Collected

- Residential well sample results from 178 homes
- Soil boring information from new monitoring wells
- Quarterly groundwater monitoring data
- Pressure transducer data from some monitoring wells
- Pre-planting and post-harvest soil samples
- Twice yearly samples of manure
- Seepage rate data for some lagoons

What form will the data be in?

- Monthly reports
- Annual reports
- Other technical reports
