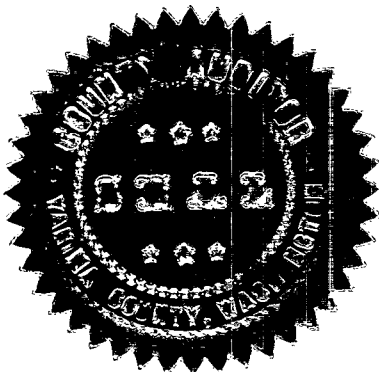

Precinct 4627 shows more ballots counted than registered voters due to a change made after programming. A correction was made to Schuler Grade Road, which increased the number of voters in precinct 4627.316 (Naches Valley School District). They were previously in Highland School District. A change to incorporate this area into the Highland School District has been processed through E.S.D. #105 but is not effective until September 2003.
