

A MESSAGE FROM YOUR COUNTY ASSESSOR

I am pleased to share this information with you, the property owners of Yakima County, again this year. Our intention is that you will find this Annual Department of Property Assessment Report informative and helpful. If there is any information that you would like to have included that is not currently here, please bring it to our attention and we will do our best to have it included.

Sales prices of homes in Yakima County were only slightly higher in 2016 than they were in 2015, up approximately 2%. Whether it is that we are isolated from the roller-coaster ride of property values or whether people are simply attracted to this area, sales prices on all types of property have remained very stable.

Depending on where your property is located in the County, most of the tax rates have gone down in 2017 over 2016, mainly the result of the State School Levy going down \$2,427,511. **The tax rates are determined by how much money the taxing districts take divided by the Taxable Assessed Value.** In total, even with the \$2.4 Million Dollar reduction by the State, Taxing Districts increased the amount of money they took by another \$1,146,194.85 over their previous highest and lawful levy.

In 2016 the Yakima County Department of Property Assessment appraised and set values on over 107,500 real and personal properties. The total value of assessments subject to property tax distribution was \$16,453,866,766. Our staff processed over 5,000 Senior Citizen or Disabled Citizen exemption requests and renewal applications across the county amounting to assessed value reductions of \$506,290,915 that creates a tax shift of \$5,572,452.50 away from these properties onto the other properties in the county. We processed 7,881 parcels in the Open Space Agricultural and Timberland programs, representing assessed value reductions of \$384,354,720 that creates a tax shift of \$4,414,595.89 away from these parcels onto the other properties in the county.






