

A MESSAGE FROM YOUR COUNTY ASSESSOR

I am pleased to share this information with you, the property owners of Yakima County, again this year. Our intention is that you will find this Annual Department of Property Assessment Report informative and helpful. If there is any information that you would like to have included that is not currently here, please bring it to our attention and we will do our best to have it included.

Sales prices of homes in Yakima County were significantly higher in 2017 than they were in 2016, up approximately 9.5%. Whether it is an aspect of the overall economy, or whether people are simply attracted to this area, sales prices on all types of property have increased dramatically.

Depending on where your property is in the County, the tax rates have gone up in 2018 over 2017 by varied amount, specifically as the result of the State Legislature adding a new levy to fund basic education as well as voter approved levies for schools. In total, including the new addition of \$18,423,567 to the State School Levy, Taxing Districts are levying an additional \$23,830,781 over last year.

In 2018 the Yakima County Department of Property Assessment appraised and set values on approximately 108,000 real and personal properties. The total value of assessments subject to property tax distribution was \$17,265,650,942 . Our staff processed over 5,000 Senior Citizen or Disabled Citizen exemption requests and renewal applications across the county amounting to assessed value reductions of \$496,195,366 that creates a tax shift of \$4,439,173.20 away from these properties onto the other properties in the county. We processed 7,809 parcels in the Open Space Agricultural and Timberland programs, representing assessed value reductions of \$407,075,955 that creates a tax shift of \$5,036,976.51 away from these parcels onto the other properties in the county.






