A. SUMMARY OF RECOMMENDATIONS

Staff recommends Approval of the requested Development Regulation Text Amendment, subject to consideration of testimony from neighbors and interested parties.

B. SUMMARY OF REQUEST

The applicants are requesting a development regulation text amendment to YCC Title 19 to allow for crematoriums when associated with funeral homes in the General Commercial (GC) zoning district. The GC zoning district currently allows funeral homes *without* crematoriums as Type 1 uses. However, funeral homes *with* crematoriums are not allowed in the GC zone. The applicants are arguing that crematoriums associated with funeral homes should be allowed in the General Commercial zone. The comprehensive plan **Horizon 2040** does not provide any background or reasoning for the classification of the two similar uses.

The Planning Division staff recommendation is to permit crematoriums *associated with funeral homes* in the same zoning districts that already permit funeral homes. This would be reflected in a new row in Title 19.14 - Allowable Land Use Table. To address potential impacts crematoriums may have on neighboring properties, all funeral homes with crematoriums, when allowed, will be subject to Type 2 review, with the exception of the Suburban Residential (SR) zone, which will be subject to Type 3 review, as outlined YCC 16B.03. Type 2 review requires neighboring property owners within 300 feet to be notified of a proposal; Type 3 review requires public notification and a public hearing. Funeral homes are currently Type 1 uses in the Large Convenience Center (LCC) and General Commercial (GC) zoning districts. When Crematoriums are associated with funeral homes in those zones (LCC and GC), they will be subject to Type 2 review instead. The new row in Table 19.14-1 (Funeral homes *with* crematorium) will reflect these changes.

1 Crematoriums (in addition to cemeteries, columbaria and mausoleums) are currently permitted in the following zones as follows:

2 **C. BACKGROUND**

3 The applicants are requesting a development regulation text amendment to YCC Title 19 to allow for
4 crematoriums in the General Commercial (GC) zoning district. Specifically, the applicant is proposing
5 to expand an existing funeral home, Keith and Keith Funeral Home, to include a 2,000-square foot
6 crematorium. Keith and Keith Funeral Home is located adjacent to the Terrace Heights Memorial Park,
7 which is a cemetery and includes a crematorium. The Terrace Heights Memorial Park Cemetery is in
8 the Single Family (R-1) zoning district, which would be subject to Type 3 review in that zone, if
9 permitted today (YCC 19.14 and YCC 16B.03). Keith and Keith Funeral Home is located in the General
10 Commercial (GC) zone. Currently funeral homes with crematoriums are not allowed in the GC zone.
11

12 **D. ANALYSIS**

13 There are no policies in *Horizon 2040* that relate specifically to funeral homes or crematoriums.
14 Regulation of crematoriums and funeral homes is likely based on general compatibility principles,
15 which require different levels of review for different land uses, based on their potential impacts to
16 neighbors, traffic, etc.; and on perceptions of compatibility between the proposed use and
17 surrounding existing allowed uses. Currently, crematoriums are allowed as Type 2 or 3 uses in most
18 rural and residential zones in the County, most likely because they are associated with cemeteries.
19 Cemeteries have different impacts (e.g. larger acreage of land needed, funeral processions, etc.) than
20 funeral homes, which are generally smaller scale than cemeteries, and operate more as a business,
21 though funeral processions are also associated with funeral homes.
22

23 **19.13.020 Urban Commercial Districts (SCC, LCC, GC, HTC).**

24 (1) Legislative Intent.

25
26 (c) General Commercial District. The purpose of the General Commercial (GC) district is to
27 accommodate wholesale and retail activities with some high-density residential development.
28 This district is located only in Urban Growth Areas, primarily near and along the major arterials
29 as designated in the Comprehensive Plan. The GC district is additionally intended to:

30 (i) Provide sites for more diversified business types including non-retail commercial and
31 business uses which are primarily related to automotive traffic; and

32 (ii) Require the County's minimum urban development standards for commercial
33 developments, or the respective city's standards, whichever are higher.

34 **Washington State Rules Regulating Crematoriums**

35 The Washington State Department of Licensing (DOL) publishes a list on their web site of rules related
36 to crematories in the State. Washington State addresses cemeteries and related uses (funeral homes
37 and crematoriums) in WAC 308-47 ("Rules of Procedure for Cremation"), and RCW Title 68
38 Dispositions ("Cemeteries, Morgues, and Human Remains").
39

40 In addition, the Washington State DOL issues licenses or endorsements of funeral homes.
41 Crematoriums are required to:

- 42 • Have a license or an endorsement on your funeral establishment license to operate a crematory
43 or conduct a cremation.
- 44 • Comply with all city or county zoning, health, and ecology ordinances.
45

1 **Other County Regulations:**

2 Some, though not many, counties in Washington State regulate crematoriums in their land use code.
3 In King County, for example, Funeral Homes/Crematoriums are listed as “Permitted” Uses in the
4 Community Business (CB) and Regional Business (RB) Districts (King County Code Title 21 – Zoning).

5
6 *Staff Finding: Based on local and state rules, there appears to be no persuasive argument to prohibit*
7 *crematoriums when associated with funeral homes in the General Commercial zoning district.*
8

9 **E. PLAN OR DEVELOPMENT REGULATION TEXT AMENDMENT APPROVAL CRITERIA**

10 The approval criteria set forth in YCC 16B.10.095(5)(6) shall be considered in any review and approval
11 of text amendments to Yakima County Comprehensive Plan and any Development Regulation.
12

13 • Consistency with 16B.10.095(5)(6) Approval Criteria:

- 14 (5) Plan policy and other text amendments including capital facilities plans must be consistent
15 with the GMA, SMA, CWPP, other comprehensive plan goals and policies, and, where
16 applicable, city comprehensive plans and adopted inter-local agreements.
17

18 GMA Consistency - This proposed text amendment is consistent with all of the thirteen
19 GMA Planning goals, RCW 36.70A.020, without any order of priority.
20

21 RCW 36.70A.020(1) Urban growth. Encourage development in urban areas where
22 adequate public facilities and services exist or can be provided in an efficient manner.
23

24 *Staff Finding: The proposal meets this criterion, as it will allow for (crematoriums) in urban*
25 *areas.*
26

27 RCW 36.70A.020(2) Reduce sprawl. Reduce the inappropriate conversion of undeveloped
28 land into sprawling, low-density development.
29

30 *Staff Finding: Allowing crematoriums in Commercial Zones will not contribute to sprawl.*
31 *Crematoriums are not large scale developments, and do not convert substantial areas of*
32 *commercial land to low-intensity uses.*
33

34 RCW 36.70A.020(3) Transportation. Encourage efficient multimodal transportation
35 systems that are based on regional priorities and coordinated with county and city
36 comprehensive plans.
37

38 *Staff Finding: Crematoriums will not affect transportation systems. Traffic associated with*
39 *funeral homes is not related to crematoriums.*
40

41 RCW 36.70A.020(4) Housing. Encourage the availability of affordable housing to all
42 economic segments of the population of this state, promote a variety of residential
43 densities and housing types, and encourage preservation of existing housing stock.
44

45 *Staff Finding: This proposal will not affect housing affordability.*
46

47 RCW 36.70A.020(5) Economic development. Encourage economic development
48 throughout the state that is consistent with adopted comprehensive plans, promote

1 economic opportunity for all citizens of this state, especially for unemployed and for
2 disadvantaged persons, promote the retention and expansion of existing businesses and
3 recruitment of new businesses, recognize regional differences impacting economic
4 development opportunities, and encourage growth in areas experiencing insufficient
5 economic growth, all within the capacities of the state's natural resources, public services,
6 and public facilities.

7
8 *Staff Finding: The proposal will have minimal effect on economic growth.*

9
10 RCW 36.70A.020(6) Property rights. Private property shall not be taken for public use
11 without just compensation having been made. The property rights of landowners shall be
12 protected from arbitrary and discriminatory actions.

13
14 *Staff Finding: The proposal will only affect private properties, and will not prevent property*
15 *owners from developing their land; nor will it affect any public uses.*

16
17 RCW 36.70A.020(7) Permits. Applications for both state and local government permits
18 should be processed in a timely and fair manner to ensure predictability.

19
20 *Staff Finding: Construction and operation of a crematorium will be subject to all applicable*
21 *state and local laws.*

22
23 RCW 36.70A.020(8) Natural resource industries. Maintain and enhance natural resource-
24 based industries, including productive timber, agricultural, and fisheries industries.
25 Encourage the conservation of productive forestlands and productive agricultural lands,
26 and discourage incompatible uses.

27
28 *Staff Finding: The proposal will only affect land within Urban Growth Areas that are zoned*
29 *for commercial purpose. The proposal will have no effect on natural resource-based*
30 *industries.*

31
32 RCW 36.70A.020(9) Open space and recreation. Retain open space, enhance recreational
33 opportunities, conserve fish and wildlife habitat, increase access to natural resource lands
34 and water, and develop parks and recreation facilities.

35
36 *Staff Finding: The proposal will have no effect on open space and recreational areas, and*
37 *project proposal would be subject to any applicable Critical Areas or Shoreline regulations,*
38 *if applicable.*

39
40 RCW 36.70A.020(10) Environment. Protect the environment and enhance the state's high
41 quality of life, including air and water quality, and the availability of water.

42
43 *Staff Finding: The proposal will only affect land within Urban Growth Areas that is zoned*
44 *for commercial purposes. Specific proposals will be required to mitigate any negative*
45 *environmental impacts, if any.*

1 RCW 36.70A.020(11) Citizen participation and coordination. Encourage the involvement
2 of citizens in the planning process and ensure coordination between communities and
3 jurisdictions to reconcile conflicts.
4

5 *Staff Finding: The Proposed Development Regulation Text Amendment will go through all*
6 *required public notice procedures, including Planning Commission and Board of County*
7 *Commissioners hearings. Future potential project permits will be subject to all public*
8 *involvement requirements as required by YCC 16B and YCC 19.*
9

10 RCW 36.70A.020(12) Public facilities and services. Ensure that those public facilities and
11 services necessary to support development shall be adequate to serve the development
12 at the time the development is available for occupancy and use without decreasing
13 current service levels below locally established minimum standards.
14

15 *Staff Finding: Any future proposals for crematoriums will be required to go through proper*
16 *permitting. Yakima County's zoning regulations prevent projects from causing a decrease*
17 *in level of service below minimum standards.*
18

19 RCW 36.70A.020(13) Historic preservation. Identify and encourage the preservation of
20 lands, sites, and structures, that have historical or archaeological significance.
21

22 *Staff Finding: Any proposal that affects historical properties or structures will be subject*
23 *to cultural resource review.*
24

25 SMA Consistency - This proposed text amendment is consistent with the Shoreline
26 Management Act, RCW 90.58.
27

28 *Staff Finding: If a proposal is located in Shoreline Management Act jurisdiction, it will be*
29 *subject to Shoreline Management regulations.*
30

31 County-wide Planning Policies Consistency - Is the proposal consistent with County-wide
32 Planning Policy.
33

34 *Staff Finding: The proposal is consistent with County-Wide Planning Policies.*
35

36 **Sub-Area Plan Consistency** – There is no applicable sub-area plan that affects this
37 proposal.

38 **City Comprehensive Plan Consistency** – There is no applicable city comp plan that affects
39 this proposal.

40 **Interlocal Agreement Consistency** – There is no applicable interlocal agreement that
41 affects this proposal.

42 *Staff Finding: This proposed text amendment is consistent with the Yakima County*
43 *Comprehensive Plan – **Horizon 2040** goals or policies.*
44

1 (6) Prior to forwarding a proposed development regulation text amendment to the Planning
2 Commission for its docketing consideration, the Planning Official must make a determination
3 that the proposed amendment is consistent with the GMA, CWPP, other comprehensive plan
4 goals and policies, and, where applicable, city comprehensive plans and adopted inter-local
5 agreements.

6
7 *Administrative Official Findings: The Yakima County Planning Commission found the proposal*
8 *consistent with all docketing requirements.*

9
10 **E. DISCUSSION OF ENVIRONMENTAL ANALYSIS (SEPA)**

11
12 LRN2018-05/SEP2018-020: Western Building Design. The applicant requests to amend the Yakima
13 County Development Regulations to allow crematoriums in the GC zoning district.

14 Staff has completed an assessment of the potential environmental impacts associated with the
15 proposed plan and zoning amendment and proposes mitigation, where appropriate.

16
17 The Environmental Checklist submitted by the applicant discloses no direct adverse
18 environmental impacts associated with the proposal. The applicant provided documentation that
19 the proposal will comply with specifications of crematorium design. The applicants submitted a
20 “Source Test Report for Particulate, Visible and Carbon Monoxide Emissions Report” which
21 documents any potential impact to the air. The new crematorium will be required to comply with
22 all regulations that are required by any regulating agency. Because the specific project is located
23 in the General Commercial zoning district, as defined and regulated by YCC Title 19, this SEPA
24 analysis is applicable to potential impacts from new proposals for crematoriums in the GC zoning
25 district. When future development applications are submitted, further environmental review may
26 be required. At that time the mitigation measures may be required to avoid probable significant
27 adverse environmental impacts.

28
29 1. *Staff Finding: No probable significant environmental impacts have been identified to result from*
30 *approval of the applicant’s request. Any future proposals will be subject to SEPA mitigation*
31 *requirements, if they are required.*

32
33 **F. CONCLUSIONS**

34
35 2. *The proposed text amendment in question meets the approval criteria outlined in Y.C.C*
36 *16B.10.095(5)(6) and should be approved.*

37
38 **G. RECOMMENDATIONS**

39
40 The Yakima County Planning Division recommends **Approval** of the **YCC Title 19 Text Amendment**,
41 subject to consideration of testimony from neighbors and interested parties.
