PROPOSITION - FIRE DISTRICT TAX LEVY:

Shall a special levy of \$7,000.00 (approximately \$.991 per one-thousand dollars assessed valuation) be collected in 1976 to meet the general operating expenses of Yakima County Fire Protection District No. 7?

Ratio of affirmative votes to total votes cast: .791




PROPOSITION - FIRE DISTRICT TAX LEVY






