

1 CERTIFICATE OF CANVASS OF SUPERVISOR OF
2 ELECTIONS, COUNTY CANVASSING BOARD AND
3 BOARD OF COUNTY COMMISSIONERS OF
4 YAKIMA COUNTY, WASHINGTON

6 We, Ray Munson, Prosecuting Attorney of Yakima County,
7 Washington, Lee Crossen, Chairman of the Board of County Commis-
8 sioners of Yakima County, Washington, Harold Purdin, Yakima County
9 Auditor and Supervisor of Elections of Yakima County and Lee
10 Crossen, Angus McDonald and Jim H. Nichols, constituting the Board
11 of County Commissioners of Yakima County, Washington, do hereby
12 certify that on this 1st day of June, 1959, at the hour of 10 o'clock
13 A.M. on said date, we duly and regularly convened in the office of
14 the Yakima County Commissioners, Room 107, Yakima County Court
15 House, in the City of Yakima, Yakima County, Washington, and duly
16 and regularly and in conformity with law, canvassed the returns of
17 that certain election for the formation of Yakima County Fire Pro-
18 tection District #10 held on the 26th day of May, 1959, at the
19 Castlevale School, 2902 Fruitvale Blvd., Yakima, Washington, to
20 determine the following proposition:

21 PROPOSITION:

22 Shall the territory bounded as follows:

23 Beginning at the intersection of the Yakima City
24 limits and North 4th Street in Section 18, Township
25 13 North, Range 19, E.W.M., thence North to the cen-
26 ter of the Yakima River; thence northwesterly along
27 the center of the Yakima River to the junction of
28 the Yakima River and the Naches River in the South-
29 east quarter of the Northeast quarter of Section 12,
30 Township 13 North, Range 18 E.W.M., thence Westerly
31 along the center line of the Naches River to the
32 junction of the Naches River and Cowiche Creek in
the Northeast quarter of the Southeast quarter of
Section 9, Township 13 North, Range 18 E.W.M.,
thence southwesterly along the center line of Cowiche
Creek to its intersection with the north line of
Section 16, Township 13, Range 18 E.W.M., thence
west along the north line of said section 16 to the
northwest corner of same section; thence south along
the west line of Section 16, Township 13 North, Range
18 E.W.M., to the southwest corner of said Section
16; thence east along the south line of Section 16,
Township 13 North, Range 18 E.W.M., to the point of
co-incidence with City of Yakima city limits;
thence easterly and northerly along the city limits of
said City of Yakima to the point of beginning exclud-
ing any and all lands within the city limits of Yakima,
all lands in the above-described area situated in the
county of Yakima, State of Washington.

be organized as YAKIMA COUNTY FIRE PROTECTION DISTRICT No. 10, of
Yakima County, Washington,

and to elect three (3) first Fire Commissioners for said Rural Fire
Protection District, and find that 222 persons voted at said
special election and that there was 201 votes cast in favor of the
proposition and 20 votes cast against the proposition, and that the

1 following votes were cast for first Fire Commissioners of said
2 Fire District; PHILIP NAUD received 179 votes, MIKE INGHAM re-
3 ceived 171 votes, and O. H. ERICKSON received 169 votes.

4 We, therefore, declare that the Proposition, as above-
5 stated, carried by more than a three-fifths (3/5) majority of
6 all votes cast at said election, and that PHILIP NAUD, MIKE ING-
7 HAM and O. H. ERICKSON received the highest number of votes for
8 first Fire Commissioners and were duly elected first Fire Commis-
9 sioners of said District.
