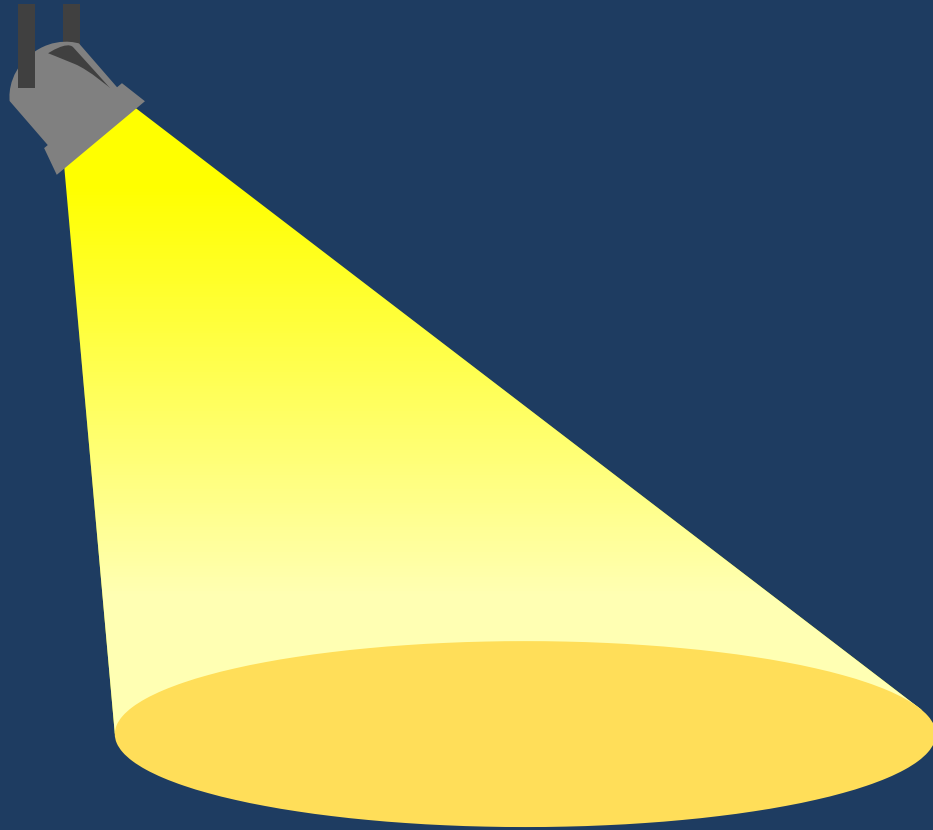

ENVIRONMENTAL HEALTH

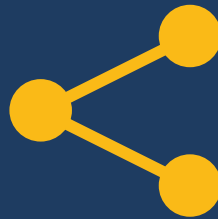
Inspecting systems and establishments that affect the community's health.

- Hub and Spoke Model launched October 2018
 - Comprehensive Healthcare staff screens Syringe Exchange Clients
 - Clients are referred to Comprehensive Healthcare for MAT

- Why?**
- YHD able to provide preventative and treatment-based services to clients
 - Allows treatment services to be more accessible

What?

- FDA grant provided funding for training on standardization of food inspection measures

Why?

- FDA measures allow for increased standardization for business owners
- FDA training allowed YHD to implement a different health inspection model that identifies risks and opportunities for public education

Who?

- Yakima Health District
- Benton-Franklin Health District
- Rod's House
- Faith-based organizations

What?

- Surveillance of advertising related to tobacco and vaping products within a .5 mile radius of schools

Why?

- Data collected from surveying is critical for future prevention efforts
- Builds knowledge of youth on marketing tactics used in our community
