GLADE AREA AND REQUESTING A
SPECIAL ELECTION

RESOLUTION

WHEREAS, on the 15th day of July, 1965, a petition of the Commissioners of the Port of Sunnyside to enlarge the Port of Sunnyside to include territory in the Mabton-Glade area and requesting a special election was filed with the Yakima County Auditor and by him transmitted to this Board; and,

WHEREAS, said petition describes the territory proposed to be included in the Port of Sunnyside and requests that a special election be called thereon on Tuesday, September 14, 1965; and,

WHEREAS, pursuant to the provisions of RCW 53.04.080, it is incumbent upon this Board at the next regular meeting after receipt of said petition to call a special election not less than 30 nor more than 60 days from the date of filing said petition; and,

WHEREAS, it appears that a special election should be called on the aforesaid proposition to enlarge the Port of Sunnyside on Tuesday, September 14, 1965; now, therefore,

IT IS HEREBY RESOLVED by the Board of County Commissioners of Yakima County, Washington, that a special election be and it is hereby called for Tuesday, September 14, 1965, on the proposition for the enlargement of the Port of Sunnyside to include territory in the Mabton-Glade area.

IT IS FURTHER RESOLVED that the Yakima County Auditor be and he is hereby requested to take whatever action is necessary to call the said election and to give notice of said election as required by law, which notice shall state the boundaries of the proposed enlarged district and the object of the special election.

RESOLUTION DECLARING ENLARGEMENT
OF THE PORT OF SUNNYSIDE

WHEREAS, a Special Election was duly held on the 14th day of September, 1965 within the area hereinafter described, for the purpose of submitting to the electors within said area hereinafter described the proposition of enlarging the limits of the Port of Sunnyside so as to include therein the whole of said property herein-after described; and,

WHEREAS, the official election returns for said Special Election have been officially canvassed as provided by law; and,

WHEREAS, the majority of the voters voting upon the proposition within the area hereinafter described have voted in favor of the enlargement of the Port of Sunnyside so as to include in said Port of Sunnyside the territory hereinafter described; now, therefore, pursuant to the provisions of RCW 53.04.100,

IT IS HEREBY RESOLVED, ORDERED AND DECLARED that the Port of Sunnyside, Yakima County, Washington, shall be and the same hereby is enlarged so as to embrace within the limits thereof the territory situate in Yakima County, Washington, described as follows, to-wit:

Beginning at a point where the North boundary of Yakima County intersects the Range line between Ranges 21 and 22, E.W.M.; thence East along said North boundary line of Yakima County to the mid-channel of the Columbia River; Thence Southeasterly along the mid-channel of the Columbia River to its intersection with the east boundary of Yakima County; Thence South along the East boundary line of Yakima County to the Southeast corner of Section 12, Twp. 12 North, Range 23, E.W.M.; Thence West to the Northeast corner of Section 14, Twp. 12, North, Range 23, E.W.M.; Thence South to the Southeast corner of said Section 14;

Thence West to the Southwest corner of said Section 14;
Thence South to the Southeast corner of Section 22, Twp. 12
North, Range 23, E.W.M.;
Thence West to the Southwest corner of said Section 22;
Thence South to the Southeast corner of Section 33, Twp. 12
North, Range 23, E.W.M.;
Thence West to the Southwest corner of Section 31, Twp. 12
North, Range 22, E.W.M.;
Thence North along the West lines of Sections 31, 30, 19,
18, 7 and 6 in Twp. 12 North, Range 22, E.W.M. to the
Northwest corner of said Section 6;
Thence North along the West line of Section 31, Township 13
North, Range 22, E.W.M. to the Northwest corner of said Sec. 31;
Thence East along the North lines of Section 31, 32 and 33,
Twp. 13 North, Range 22, E.W.M. to the Southwest corner of
Section 27, Twp. 13 North, Range 22, E.W.M.;
Thence North along the West lines of Sections 27, 22, 15, 10
and 3 in Twp. 13 North, Range 22, E.W.M. to the Northwest
corner of said Section 3;
Thence West along the North lines of Sections 4, 5 and 6 to
the Range line between Ranges 21 and 22, E.W.M.;
Thence North along said Range line to point of beginning.

BE IT FURTHER RESOLVED, DECLARED AND ORDERED that the boundaries
of said Port of Sunnyside as hereby enlarged by the inclusion therein
and the annexation thereof of the additional territory hereinabove
immediately described shall be so enlarged and the Commissioners
thereof shall have jurisdiction over the whole of said district as
enlarged to the same extent, and with like power and authority, as
though the additional territory had been originally embraced within
the boundaries of the existing Port of Sunnyside: PROVIDED, HOWEVER,
that none of the lands or property embraced within the territory added
to and incorporated within said Port of Sunnyside shall be liable to
assessments for the payment of any outstanding bonds, warrants or
other indebtedness of such original Port of Sunnyside.
