HNY – Housing Profile


- Focus on housing stock

5-YEAR PLAN UPDATE

Review and feedback

5-YEAR PLAN DESIRED OUTCOMES

- Streamline current plan by consolidating redundant goals/tasks and removing cumbersome/unsupported goals/tasks
- Create measurable outcomes for goals/tasks and identify data sources to track them
- Develop goals that are realistic, effective, and fundable
 - ⇒ Goals that align with State Objectives
 - ⇒ Goals that are supported by existing opportunities and work
 - ⇒ Goals that respond to needs within our community
- Assess status of final goals



State Objectives (must be included in Local Plan)

1 Quickly identify and engage people experiencing homelessness

2 Prioritize housing for people with the greatest needs

3 Operate an effective and efficient homeless crisis response system that swiftly moves people into stable permanent housing

4 Project the impact of the fully implemented local plans on the number of households housed and the number of households left unsheltered, assuming existing resources and state policies

5 Address racial disparities among people experiencing homelessness

Current Local Plan Goals

1. Utilize a Coordinated Entry, Assessment and Referral System
2. Coordinate funding for Homeless Programs
3. Develop additional Shelter beds with access to services and maintain existing resources
4. Create additional Rapid Re-Housing options to provide a transition from homeless shelter to more permanent housing
5. Expand Permanent Supportive Housing options and prioritize services and housing for chronic homeless families and individuals using Coordinated Entry
6. Facilitate continued data collection efforts and share data between all programs
7. Prevent Homelessness when possible
8. Build the Community and Political commitment to end homelessness in our County
9. Better serve youth homelessness
10. Increase Capacity to add employment opportunities for self sufficiency
11. Increase Transparency of Program funding and services provided and Monitor program performance with measurable benchmarks

QUICKLY IDENTIFY AND ENGAGE PEOPLE EXPERIENCING
HOMELESSNESS THROUGH OUTREACH AND COORDINATION
BETWEEN EVERY SYSTEM THAT ENCOUNTERS PEOPLE
EXPERIENCING HOMELESSNESS

- 1.1 Design, implement, maintain, and utilize an efficient and compliant Coordinated Entry (CE) System**
- 1.2 Improve outreach to identify individuals experiencing homelessness and encourage participation in services through CE or BNL**
- 1.3 Use Vulnerability Index (VI-SPDAT) in CE to prioritize services for people with the greatest need**

02 OPERATE AN EFFECTIVE AND EFFICIENT HOMELESS CRISIS RESPONSE SYSTEM THAT SWIFTLY MOVES PEOPLE INTO STABLE PERMANENT HOUSING

- 2.1** Increase exits to permanent housing from Emergency Shelter (ES) to 26% by June 30, 2020
- 2.2** Increase exits to permanent housing from Rapid-Rehousing (RRH) programs to 80% by June 30, 2020
- 2.3** Increase exits to or retention of permanent housing from Permanent Supportive Housing (PSH) programs to 92% by June 30, 2020
- 2.4** Increase percent unsheltered served by homeless response system to 49% by June 30, 2020
- 2.5** Reduce returns to homelessness after exit to permanent housing to less than 10% by 2022
- 2.6** Reduce average length of time homeless of those served to less than 90 days by 2022
- 2.7** Increase percentage of exits from street outreach to positive outcome destinations as defined by HUD System Performance Measures to >76% by 2022
- 2.8** Increase system-wide percentage of exits to permanent housing to >59% by 2022
- 2.9** Continue to provide the services, infrastructure, and resources that make up the homeless crisis response system, including: low-barrier overnight shelters (including cold-weather emergency shelter), domestic violence shelters, day-shelters, respite, case management, prevention, diversion, rental and eviction assistance, supportive housing, transitional housing, housing choice vouchers, drug and alcohol rehabilitation programs, mental health programs, and employment assistance

03 SUPPORT THE DEVELOPMENT OF ADEQUATE AFFORDABLE HOUSING

- 3.1** Support potential capital projects for building low-barrier PSH
- 3.2** Partner with landlords to increase willingness to rent existing housing to clients with history of homelessness
- 3.3** Support affordable housing initiatives for new construction of low-income units such as accessory or efficiency housing
- 3.4** Support construction of new low-income housing with appropriate program supervision
- 3.5** Support and increase landlord tenant counseling

04 TRACK AND PUBLISH DATA REGARDING HOMELESSNESS IN YAKIMA COUNTY

- 4.1** Project the impact of the fully implemented local plan on the number of households housed and the number of households left unsheltered, assuming existing resources and state politics
- 4.2** Continue to use and promote the shared enterprise of County-wide HMIS database
- 4.3** Support accurate and consistent Point in Time data collection efforts
- 4.4** Create and utilize visual reports/aides to provide transparency regarding program performance and clients being served
- 4.5** Monitor and track program performance to ensure performance targets are being met and make results known to all stakeholders
- 4.6** Track available housing through the Housing Inventory Chart (HIC)

ADDRESS DISPARITIES AMONG PEOPLE EXPERIENCING HOMELESSNESS

- 5.1** Analyze racial disparities using a racial equity tool and data provided by Commerce
- 5.2** Seek data sources for tracking LGBTQ* disparities
- 5.3** Engage with agencies including, but not limited to, School Homeless Liaisons, Rod's House, Henry Beauchamp Community Center, YNHS LGBTQ Youth Resource Center (The Space), and Catholic Families Youth to identify youth and determine their specific needs
- 5.4** Create a safe overnight facility for Youth and Young Adults (YYA) experiencing homelessness
- 5.5** Support after-school programs to encourage YYA mentoring in a safe environment
- 5.6** Create partnerships to advocate for youth homelessness issues and educate providers on legislatively acceptable strategies for addressing the needs of youth
- 5.7** Increase opportunities for LGBTQ* youth experiencing homelessness to access support, resources, housing, and family reunification when possible
- 5.8** Design, implement, maintain, and utilize an efficient and compliant By-Name List (BNL) for YYA experiencing homelessness
- 5.9** Design, implement, maintain, and utilize an efficient and compliant BNL for veterans experiencing homelessness
