ORDINANCE 1-2020

IN THE MATTER OF AMENDING THE STORMWATER REVIEW FEE SCHEDULE ESTABLISHED BY YAKIMA COUNTY CODE (YCC) CHAPTER 20.01.060 OF TITLE 20.01, YAKIMA COUNTY FEE SCHEDULE

WHEREAS, the Board of County Commissioners of Yakima County, Washington, created the Stormwater Management Utility through the adoption of Ordinance 11-2007 on December 18, 2007; and,

WHEREAS, Resolution 485-2008 created a separate Stormwater Utility Fund No. 126 in accordance with RCW 36.89.080(4); and,

WHEREAS, the ordinance provided that the stormwater utility boundary shall be reviewed and amended annually by the Public Services Director; and,

WHEREAS, the Public Services Director did review the stormwater utility rates and boundaries; and,

WHEREAS, the Public Services Director recommends that the stormwater review fee be revised to include no fee for the first review; and,

WHEREAS, the amending the fee schedule was advertised on the 20th and 27th of November and the 4th of December 2019 issues of the Yakima Herald-Republic newspaper; and,

BE IT HEREBY ORDAINED by the Board of County Commissioners of Yakima County Washington, that Chapter 20.01.060 of Yakima County Code Title 20.01 is amended as follows:



(5)	<p>Appeals to the Public Services Director (YCC <u>12.10.270</u>)</p>	\$1,410.00.
<p>* "Processing cost" means actual costs including but not limited to staff wages, benefits, overhead, consultant services or other expenses incurred in the processing of the review of the project subject to YCC Chapter <u>12.10</u>. The hourly rate listed below includes wages, benefits, and overhead for planning, managerial, and clerical staff, and is assessed based on the time expended by Yakima County staff only.</p>

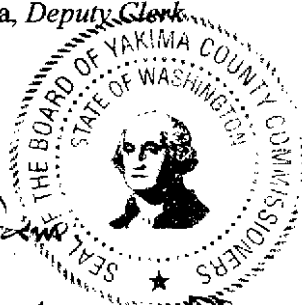
